So let's start with the Better World Fund. The Better World Fund was started many years ago when Abby actually was the minister.

It started with a donation from the family of Ruth Anderson.

All They had given a \$10,000 donation to the social justice council, and we had decided to build this Better World Fund.

The purpose of the Better World Fund was threefold. One was that every year we would give \$1,000 to a local group that was helping the homeless because Ruth Anderson was very interested in the issues around homelessness.

And at that time, we had also committed \$1,000 a year to the minister's discretionary or benevolent fund, but we don't do that anymore because the minister had gotten a large donation that funds that fund.

So we don't do that anymore. And then the third way we were using it was for emergencies around. So over the years, in terms of the hurricane, last year we gave a lot of money to the UUA Hurricane Emergency Fund to help support UU ministries around the nation that were hit with hurricanes, and we also gave money to Feeding Tampa Bay for the work that they were doing for hurricane relief in our communities.

So that varies, and we've used it over the years a lot of different ways, but it's all been around emergencies that have happened in our world that need immediate, you know, help. Sometimes it was done in conjunction with asking for the congregation, but sometimes it wasn't. Sometimes it was just in lieu of going back to the congregation for money that we would use this fund.

trying to band. was like you. So, since it started, every year, the Anderson family has given a donation from the trust of Gene Anderson, and they usually, what is given is, from Robert Anderson, her son, \$2,000 a year, it usually comes around November or December.

Last year, I looked it up and it came in December, we always, I had, I had spoken with Robert Anderson, sent him a thank you note to the Anderson family and so forth, and let them know how it was used during the year.

In addition, some years, we've gotten additional money from other members of the Anderson family, grandkids and whatnot, which is always welcome and, and we're happy to get it. So that's, so that's, so story, story. Um, with the, um, Better World Fund, we have been giving \$1,000 a year from the Better World Fund to HECC, um, as the agency that helps the homeless in our community.

Um, and that usually happens in June, and I forgot, I didn't write the check for that. So, um, that's something that we probably, if we want to continue doing that, that's something that needs to be done.

But then we started getting some really negative feedback about that the services there had really gone downhill. And we had decided back at that time that we didn't want to be supportive of that. back at that time And then we, of course, we made our connections with Hep and so on, so that's why we give it to Hep now.

So the other thing that I thought about, and that when Bob, when you raised this, is that, you know, if anyone hears about an emergency or wants or thinks there's something that we should do, be giving money to from the emergency fund, we need to, you know, it's open to anyone to do that and to make the suggestion.

And in fact, sometimes it's done even in years past in between our meetings because it's an emergency. And I'll, and I'll just tell people that this has been suggested and we vote, you know, online for it.

So. So, yeah, so that's big, you know, so it really is open for people to use.

So she's been, she still has contact with those families, but that committee has not been, they, you know, were doing the ESL, they're not doing that anymore.

And so the committee has not really been operating. So I really, I, I really think that we have to wait until Barb, you know, Barb and Bill are away.

And I think we have to wait until Barb and Bill come back. So we can discuss it with Barb and see what, how she wants to expend those funds.

Cause it really is not, it's sort of different. But that's why that line was put in there. That's not a continuing fund that people should be contributing to.

So he's going to be a little bit. Okay. Okay. Fast and confusing, perhaps. So last week, a couple of weeks ago, probably the 20th, we had a two-complementary, oh, this is, by the way, the report for the UUC Food Forests and Gardens Committee.

Two weeks ago, or one week ago, I forgot, sorry. We had a couple of complimentary events. One was for the community extreme heat training.

And the other one was for, which was related, but you didn't look on the flyer, seed bombs. What happens when you're working in your garden and nothing takes because it's too hot.

So we came up with this concept of seed bombs that are resistant. The seeds resist the heat and they thrive.

So instead of having nothing in your garden, you will have something. Plan B, that's what I call it. It was well attended.

We had about 60 people. So we were very happy that a lot of people came, especially from the Facebook promotion.

that we did, people who came from other cities, just to do this training. So it was very encouraging. Of course, this was also part of the Alianza activities.

So we had a lot of Puerto Rican people. So half of the meeting was in Spanish, which was really funny.

And so... But it was it was kind of good. So people were delighted and we were able to give them gear for them to prepare if they are working outdoors.

October 18 is our next volunteer day. I know it conflicts with the King's protests, but these we did about three months ago.

We picked the date because, as you know, I've been working on a partnership with Eckhart College. And so they finally said yes.

And so right now we only have the volunteer part of it. But we are forming an internship program in which the farm students that they have can come and do an internship in our forest.

So we are very excited about that. On the 18th, we're going to have about 20 students who will come and work in the forest, we're trying to make that a monthly event with them, they are very excited about building things in the garden, because they have three master carpenters, they also have people who, they have a compost club, so they want to bring the compost club to do our compost, not to do it, but to keep it up and so that we, our compost pile and station thrives. So we are very happy about that. So we're working on little projects here and there. What we're going to be doing on the 18th is our banana trees are having babies, so to speak.

So those little writing songs are going to be cut off and put everywhere else. There's about 30. We of them that need to be replanted, so we're very happy about that, that what we're doing is working and our plants are grateful in reproducing, so that's very good.

We are also going to do a harvest for a plant that is called Ojasanta. I don't know if you know this plant.

It's something that is a medicinal plant, and we're trying to contact. I don't know if it will be possible because of the day and because of the situation, but we would like the Mexican community to come and take some of these harvesting.

They are the ones who use it the most. Central Americans also use it. And so, we'll see if we can get anybody to come and be the recipient for this, because this is a very...

... If you buy it in the market, it's very expensive, and so having the opportunity to have it for free, you know, that would be great, but we'll see if we get the community to come.

That day, we'll also are preparing a very special gardening class. We are trying to teach the kids how to build a fairy garden, and the reason why we're doing not vegetables, well, we aren't going to plant vegetables in the fairy garden, but the reason why we are kind of going away from the regular type of classes is to entice kids to have a fairy garden, and for them to like it, and then come back for other kinds of classes.

So, I- So II have a friend who is an expert in fairy gardens. She's going to donate her time. She's sold fairy gardens all over Pinellas County. It's part of her art. So she's going to be teaching the class.

We're trying to collect right now materials for the fairy gardens so that we can use recyclable things for the houses, for everything that we're going to put in there.

I may ask for a call for donations. If people have fairy figurines, you know, those are very expensive. And so it would be nice to not to have to spend a lot of money on that.

So that is what we are working on for that. As I mentioned, we secured um, Partnership with Acre College, and we are also secure partnership with USF and the Mellon Foundation, but this is only for the teaching garden, but yesterday was the first time, the first video that we released with the students, they are going to be doing stories about what's growing in the garden, and so the USF Mellon Foundation, they are very excited about our kids because I'm really promoting them, you

That's how to connect with nature, with forests, with the gardens, and how to be inspired to be creative. So we are very, they are maybe a sponsor for this, they sell seeds, and so we're trying to figure out how to incorporate the sponsor, the seeds, the nature, the art, and see how we can all work together.

We've proposed putting a new tab at the top of the website, so where the tabs are currently the things that say like home, calendar, about us, Sundays, find your place.

We've proposed putting in there a new tab for social justice. This tab would have 10 different individual pages under it.

They would be available on kind of a drop-down menu, so when you click on social justice, you'll see a menu comes up of drop-down options.

And each of these options would have, for the most part, would have an individual social justice initiative under them.

There would be at the top, there would be one kind of general welcome to social justice. It's a message from Linda about UU values and social justice with links to all the individual activities that social justice does, as well as

The video that I made about Side with Love, and a link to the social justice calendar, then under that we would have individual pages for Beacon Food Forest and Gardens, Democracy Advocates Team, Environmental Justice, FAST, Racial Justice, Refugee and Immigrant Team, Welcoming LGBTQ, and then one for partner organizations.

These would be things like Hispanic Outreach Center, Interfaith Tampa Bay, NAMI, PFLAG, United Faith's Walk of Peace. These are activities that our social justice is obviously very involved with, but they're not initiated by us, so we're putting them on a partner page.

We're going to have a Learn More page, which would include the minutes from the Social Justice Council, as well as the Social Justice History.

Those are in different places on the website now. They've moved to this. This new site. One thing we are going to do is we're going to leave under the find your place at UUC tab.

There's currently a web page for the garden and we're going to leave that there. So the garden essentially is going to have two pages.

And Bill, you're on. Thank you for your patience. No worries. When I was charged to make the frame, my instructions were to design and build something that we could reuse, that whatever we put up would be protected by a clear plastic front.

And that would, we knew it would be vandalized to a point. And the last time it had gotten vandalized, I tried a bunch of chemicals.

We got it down to the isopropyl alcohol, which was able to clean off the paint without destroying the plastic.

That's the goal, is to try to remove something from plastic that you don't fog it or dissolve it, which there are plenty of chemicals that would do it.

I narrowed it down to the isopropyl 99% alcohol. What was a surprise to me was two Sundays ago, I was sitting in the social hall and Reverend Amy came to me and said, oh, did you see that the sign had been vandalized again?

And I said, yes. And she said, and now we tried everything to clean off that paint and we couldn't find anything to clean it off.

And I said, and I said, well, the alcohol worked. And she said, well, how did you know? And I said, I was there, you know, I was the one who was doing it.

I was the one testing it. And she said, we tried. It was me that tried it all. So unfortunately, right now, you have five layers of paint on the plastic.

When it wasn't cleaned off the third time, it was painted over. So that painted over and then again and then again, I don't know if you can salvage that clear plastic now.

But my question for you guys were, was mainly, what did you do with the picture of the person that did it last time?

Did you send it to the police or did you do anything with that?

To my knowledge, nothing was done with that picture. Okay. We were all sort of surprised that he was an African-American.

So that's kind of defeats the purpose of having a camera there. My reason why I wanted to talk to you today was there is another way of discovering who this person is.

On social media, on TikTok, on many platforms, they have people that will investigate who it is. You know, they'll put up what we have, we send them and say, do you know who this is?

And then they find out who it is and see if they can get an explanation from what instead of going to the police and, and doing it that way.

My two part question is, right now, I don't think you can Cleaning that plastic, there's so much paint on it, and you're going to have to replace the clear plastic again.

You wanted to replace the sign and I designed it so the one side could come off and you can slide a new sign in there and then slide the plastic in and out also.

And it is secure onto the wall with concrete screws. So a couple of questions here. One, we have to be able to clear the view of the camera permanently.

I mean you can't keep trimming back a branch that keeps growing in front of the camera. That needs to be cut off, that branch from the tree.

So it can't grow back and cover the camera. So that's one thing so we can find out who's doing it, because it might be somebody new now.

And we don't know who it is that's doing it. So the first step one is to get your intent on what we want to do with it.

Just face the fact that it's going to be vandalized and even though Reverend Amy didn't I don't know how she didn't know that the alcohol cleaned off the sign, but in the future, you know, obviously, that's what you're going to have to do is just clean it off each time.

I wasn't there for you to do that, Linda, when you had that day, but you did a good job of cleaning the whole sign pretty clean.

It was pretty amazing.

The other thing that Reverend Amy did this time is she put a note on the sign to the person saying, hey, person who keeps disfiguring the sign, what's your problem with the sign?

Please, she put her phone number on there, please talk to us and see if, see and share what your problem is with the sign.

Maybe we'll agree. And so that little note has been up there since she resprayed it the last time. She has not, to my knowledge, gotten a call about it.

And the first, what Reverend Amy was talking about is she did some, you know, it was sort of you, when you found the alcohol and you've cleaned it and then you.

You said that this was a lot of, you know, this was more than you could, you'd want to take it on as your responsibility, basically, she did some work using Mr.

Clean and other stuff, and then I finished it with using the alcohol, and that's when we got it clean the last time, just for your information, so that, just for that, that's just information.

Right.

So I'm getting, basically, is that your still intent is to change the sign, uh, eventually? Yes. Okay, so then, obviously, you're going to have to change the plastic, because you can't have a big black section missing out of it.

Yes. So that means you're going to have to change the plastic, and then if you're going to change the plastic, then you're going to have to have a clear view with the camera, so we can get an idea, and then make a decision what you want to do with those pictures, that you get, of who that is.

Now, we have, I do have the picture. Of. Or have access to the pictures of the person, but if that's

not a current person that's defacing it, then I don't want to even attempt to give it to these investigators that just do it because it's what they do on TikTok is they just find out who it is and where they go, where they work and shame them.

Basically, they just shame them from doing things that they shouldn't be doing because it is illegal. I mean, you're defacing private property.

You're on private property. So there are factors that we have to take in consideration. So my thought is if you're going to leave, obviously, you have to leave it the way it is now.

And I would, of course, assist you when you want to change the site, too, because it's going to take a little bit of knowledge on how to do that because I had to rig it so it would hold a different size because I've made two trips, you know, one to cut the plastic and and

Linda, told you this, when you ask for a four by eight piece of anything, anywhere, it's not four by eight, it's not 48 by 96, it's 48 and a half by 96 and a half, or 48 and a quarter, you know, it's not 48 by 96

So in that instance, I had to go to those places and have the sign recut, which they denied that they cut it because it was all jagged, you know, when you said the lady did it without the machine. But they recut it to the size they needed it, they recut, we want to pick up the plastic, you said it's done and I said it's now 48, 96 exactly, right?

No. So they had to recut it again for me to get it. So I did wait for that to be done and I did mount it and put it on.

But the advantage of having the clear plastic and the advantage of the fact that we can clean it if they just use it, it's not a, it's not

A water-based paint when they put it on, it's just a strong paint, but it did take it off. So my question is, if in the future when you do change the sign and you're now you're going to have to change the plastic, do you want to go with the thought of following through with someone who might investigate it or do you want to go to the board to do that, to think about that?

Does that make sense to you, my question?

There's something upsetting, you know, because we've got other banners there that say very, we talk about, we have a rainbow banner that says love is love hanging there.

We have another banner, we says UUC welcomes refugees, they're all hot issues, so to speak, in today's day, but that's the only one that gets vandalized.

It's not fabric, so it would stay in place when we put it. I made it, I designed it so it would put enough pressure on whatever you use as a sign that's relatively stiff that you're not going to get bubbles and waves in it.

It'll be nice and clean. That's the way I built it. So my point and my question is, if you're going to change a sign, you're going to have to pay to now get another piece of plastic because it's been run. So if you're going to do those things, have this information available as what the board's intent is with the camera, with the protection like that,

With seeing who's doing it, it seems ridiculous to me to, to, to keep, it's like, it's like being in a boat that's leaking and you take a bucket of water, you know, a cup and three and throwing water out of the boat, instead of fixing the hole, you know, so there's a lot of factors that, that went into this to get this protected and done, and a lot of time and effort and energy from me.

So, basically, when we're ready to change that sign, and I'm saying we, because I'm going to have to help you do it, I don't want, again, to be painted over and over and over again, if they didn't like something, we have to have some result.

It's not a big deal, it's only a, it's a tiny. Any little branch. It's not going to hurt the tree. I'm going have my trees cut constantly. It's not an issue of a tree.

So the person may not answer the question that Reverend Amy put on the sign. So if we get a clear picture of the person, we may also want to think about that this person may not be in their clear mind.

And so I'm just throwing that in there. I know that I'm not helping the issue, but it's something that if we're going to do something about it, let's think about that, too. you. Thank So that's all I wanted to say.
